It is estimated there are at least 3000 cult groups, small and large, operating within Australia.

The behaviour and actions of some of these groups results in a legacy of mental, physical and financial damage to individuals and families, from which many may never fully recover.

Freedom of religious belief is a fundamental right, but groups which perpetrate abuses and hide behind this important freedom must still be held accountable.

There is a gradually increasing awareness in Australia, among politicians, mental health professionals, human rights advocates and the general public, that the fundamental right to freedom of religion cannot be used to justify abuse.

The objective of the conference is to focus attention on and recommend safeguards against the serious harm caused by cults in Australia.

This Conference will evaluate the measures taken by other countries to protect their citizens from cults, and seek to identify the political, legal and educational strategies needed to address what is a major problem in this country.

Many attempts have been made over the years to lobby for solutions and address serious issues affecting families, children, individuals and ultimately society from groups which have caused abuse and harm.

This Conference aims to bring about responsible debate and action on behalf of Government to protect Australian society and its citizens, including to:

- Establish a body to hear and investigate complaints of abuse;
- Adopt a criminal offence of "intentionally or recklessly causing psychological harm" as set out in the 1998 Model Criminal Code of Attorneys-Generals but not enacted;
- Strengthen Health Care Complaints to deal with the issues relating to "deliberately, recklessly or indifferently interfering with psychological health or access to qualified medical treatment"; and,
- Protect youth through education on the risks of cult involvement.

Attendance is free, but registration is essential.
